## **Course Objectives Classroom Training:**

- **Definitions** The students will learn and become familiar with the definitions of words and phrases used during an interview and interrogation. The following are examples of definitions the students will learn during this course: interview, interrogation, the interviewer, witness, suspect, legal issues, and canvass.
- Canvass Interviews The students will learn techniques and skills used by law enforcement professionals to gather critical information from witnesses and individuals in the vicinity of a crime scene.
- **Preparation for an Interview –** The students will gain comprehensive insights into the process of getting ready for an interview with suspects, witnesses, or persons of interest in criminal investigations.
- Legal Aspects In this presentation focused on the legal aspects of conducting interviews and interrogations in a criminal case, students will gain a comprehensive understanding of the complex legal framework that governs these crucial investigative practices.
- Verbal and Physical Behavior Students will explore the intricate dynamics of communication and body language within the context of investigative interactions. The presentation will cover techniques for interpreting and analyzing verbal cues, such as tone, language patterns, and inconsistencies, to discern truthfulness and gather accurate information.

- Causes of Denial Students will delve into the underlying psychological, social, and situational factors that lead individuals to withhold information or provide false statements. The presentation will explore the reasons behind denials, including fear, guilt, self-preservation, memory lapses, and external pressures.
- Interviewing Students will acquire a multifaceted skill set crucial for effective investigative interactions. The presentation will cover a range of topics including communication techniques, legal considerations, psychological insights, and ethical practices.
- Why People Confess Students will explore the psychological and situational
  factors that drive people to admit guilt. They'll analyze motivations like guilt, fear,
  and pressure, and examine the role of tactics and evidence. Ethical and legal
  considerations will be addressed.
- **Establishing Credibility** Students will learn techniques to build trust and credibility with witnesses and suspects. They'll explore effective communication, rapport-building, and ethical strategies to enhance the reliability of information gathered during interviews.
- **Reducing Resistance** Students will learn strategies to minimize resistance and enhance cooperation when conducting interviews in criminal cases. Techniques to manage defensiveness, build rapport, and address emotional barriers will be explored, enabling effective communication and information gathering.
- Obtaining the Admission Students will study methods to skillfully elicit admissions from subjects in criminal case interviews. They'll learn persuasive communication, active listening, and psychological insights to encourage truthful disclosures. The curriculum emphasizes ethical practices and effective strategies for gathering critical information.
- Development of the Admission Students will acquire techniques to constructively guide subjects towards admissions during criminal case interviews. The curriculum covers strategic questioning, empathy, and cognitive approaches to elicit truthful information. Ethical considerations and effective methods for fostering cooperation will be emphasized.
- The Statement Students will learn how to accurately document statements obtained from subjects during criminal case interviews. The curriculum covers note-taking, recording methods, and preserving evidentiary integrity. Emphasis is placed on maintaining detailed, unbiased, and legally admissible records.
- Ending the Interview Students will learn the art of effectively concluding interviews in criminal cases. The curriculum covers techniques for summarizing, clarifying, and ensuring understanding. Emphasis is on maintaining rapport, addressing concerns, and concluding with professionalism and respect.
- Telephone Interviews Students will learn to conduct telephone interviews in criminal cases. The curriculum covers communication skills, establishing rapport remotely, active listening and adapting questioning techniques. Ethical considerations and challenges unique to phone interviews will be addressed, enhancing students' ability to gather accurate information.
